- be a volunteer member of a emergency service organisation for a period of at least 2 years
- be aged between 18 and 23 years of age
- be available to undertake the voyage on the date nominated in the award

In addition, nominees must meet all of Young Endeavour’s mandatory selection criteria including:

- be an Australian citizen or permanent resident
- be able to swim 50 metres and be in good health
- weigh less than 120kg
- complete a medical examination to the required standard
- not having completed a voyage in Young Endeavour previously
